Financial Information: Each student applying for financial assistance scholarship must provide Rockford Dance Company with documented evidence of financial need. **Please attach a copy of the first two pages of your 2010 Federal Income Tax return to this form and enrollment form.** A letter explaining your current financial situation can also be attached. All financial information will be kept in the strictest confidence. This application **WILL NOT** be processed without financial information.

DEADLINE: Applications are due in the Rockford Dance Company office by 5:00 P.M on Wednesday, August 17, 2011.

Placement Class: New Students to RDC must attend the placement class on Saturday, August 20, 2011. *(See below for specific audition times.)* Students currently enrolled in RDC classes do not need to attend the placement class however a parent or guardian must attend the parent meeting. Applicants **MUST** arrive no later than 5:45 P.M.

PARENT MEETING: SATURDAY AUGUST 20, 2011 at 6:00 p.m. A parent/guardian of all applicants, as well as, current scholarship students, regardless of students' age, must attend a parent information meeting during the audition. Applicants will not be considered without a responsible adult attending this meeting.
